ARBITRATION RULES

The RAC administers arbitration in accordance with the Arbitration Rules 2021, which are in line with the world's best arbitration practices.

ADVANTAGES OF THE RAC ARBITRATION RULES

Flexible arbitration procedure, including expedited arbitration with no oral hearings

Consolidation of claims, already commenced arbitrations and the possibility of joining additional parties to the arbitration

Emergency interim measures prior to the constitution of the arbitral tribunal and innovative penalty payment (astreinte) for non-enforcement of interim measures Affordable arbitration fees and the possibility of agreeing on hourly rates

Communication via e-mail, online hearings and exchange of documents in the RAC Online Arbitration System

ARBITRATION RULES

REPUTABLE BOARD

The RAC Board decides on the arbitrators' appointment, challenge and termination of the mandate. The Board comprises the Subcommittee on Arbitration of Domestic Disputes and the Subcommittee on International Arbitration.

The Board consists of respected and highly qualified Russian and foreign specialists.

COMPOSITION OF THE BOARD

ENFORCEABILITY

We pay special attention to the quality of arbitral awards and follow the case law on enforcement orders and the annulment of arbitral awards rendered in disputes administered by the RAC.

During its existence, about 1,500 cases have been considered in the RAC. At the same time, the percentage of enforced RAC's awards in Russian and foreign courts is close to 100%.

Russian Arbitration Centre is the first Russian institution with an overseas office at the Dubai International Financial Centre (DIFC). The Russian Institute of Modern Arbitration has the status of a recognised foreign company (Recognised Company).

The parties may choose the RAC office in the DIFC in their arbitration clause, while the RAC Arbitration Rules 2021, including the rates of arbitration fees provided therein, will apply to the arbitration procedure.

The whole process of arbitration from filing a claim to adoption of an arbitral award could be carried out through the Online System.


Easy Access to Information and Convenient Uploading of Documents
